SIGNAGE PERMIT CONDITIONS


- Individuals granted entry into the Ak-Chin Indian Community (the "Community"), but found in other areas outside of the sign sites may be cited for civil trespassing by the Ak-Chin Indian Community Law Enforcement Officers. In addition, individuals cited for civil trespass could be fined and have their vehicles and/or equipment confiscated.
- 2. Activities which are not related directly for the purpose stated above are a violation of the granting for this Signage Permit and may be cause for the permit to be revoked.
- 3. Individuals granted access onto the Community are prohibited from carrying firearms onto Tribal land (Tribal law prohibits hunting and fishing activities).
- 4. Individuals granted access onto the Community must be aware that there are ordinances protecting archaeological and historical sites, as well as the protection of native plants. <u>The Applicant or his agents must contact the Cultural Resources Office five business days prior to any ground disturbing activity.</u> Archaeological studies or clearances will be preformed only by the Ak-Chin Cultural Resources Office. Individual(s) granted access into the Community should make an earnest effort to become knowledgeable of these ordinances, or make inquiries to the Planning and Development Department when in doubt about relating to them.
- 5. The requestor understands and hereby expressly agrees to indemnify the Ak-Chin Indian Community for work performed under this permit and will notify the Planning and Development Department at least 24 hours in advance when visits will be made onto the Community.
- 6. Individuals granted access into the Community must keep this Signage Permit in their possession at all times (copies of the permit may be made) and abide by the laws and ordinances of the Ak-Chin Indian Community.
- 7. As part of the approval of the Signage Permit, the Applicant must maintain upkeep of the approved signage(s) during its permitted time period.
- 8. Applicant must take down and/or remove the approved signage(s) once its permitted time period has expired.
- 9. Individuals granted access must restore the land as nearly as may be possible to the original condition upon the termination of the Signage Permit.










Farrell Rd - Village 11/5/2020








Farrell Rd - Mesquite Subd. 11/5/2020








Greasewood Subd. 11/5/2020
